
# Bureau of Health Workforce Awardees: 2018 At a Glance

# The Program

In calendar year 2018, thirty-eight (38) Bureau of Health Workforce awardees (BHWs) provided services to 29,115 patients with 83,609 visits. In the previous year (CY2017) there were a total of 36 awardees reporting.

# **Patients: Socioeconomic Characteristics**

- 92% have incomes at or below 200% of the Federal Poverty Level
- 36% are uninsured
- 41% have public insurance (Medicaid, Medicare, or Other Public)



### **Services Provided**

- 84% of BHWs provide primary medical care services
- 8% of awardees provide dental services
- 68% of awardees provide behavioral health services


# **Continuity of Care**

BHW awardees provide continuous care.

#### **Patients: Minority Status**

- 72% are of racial and/or ethnic minority
- 26% face a linguistic barrier



# **Staffing and Tenure**

BHW awardees employ the full time equivalent of 211 staff members and volunteers.

- 54 are physicians, CNMS, NPs, and PAs
- 39 are other clinical staff (nurses and other medical professionals)
- 26 are enabling service providers
- 1.5 are dental service providers
- 38 are behavioral health (mental health and substance use disorder)
- 47 provide non-clinical support
- Medical providers (including nurses) report an average tenure of 2.6 years
- Behavioral Health Care providers report an average tenure of 1.8 years
- Key non-clinical support staff (CEOs, CMOs, CFOs, and CIOs) report an average tenure of 4.4 years

#### **Quality of Care and Outcome Indicators: Clinical Performance**

BHW awardees provide high quality of care. Measures that exceed Healthy People 2020 goals include early entry into prenatal care, birth weight, asthma therapy, and depressing screening. Other measures show room for improvement including cervical cancer screening, colorectal cancer screening and diabetes control.
